



Knights of Columbus Funds - Estimated Year End Tax Distributions*

The Knights of Columbus Funds anticipate declaring a capital gain distribution this year for holders of the Knights of Columbus Large Cap Growth Fund (KCGIX & KCGSX), Knights of Columbus Large Cap Value Fund (KCVIX & KCVSX), Knights of Columbus Small Cap Fund (KCSIX & KCSSX) and the Knights of Columbus U.S. All Cap Index Fund (KCXIX) (“Funds” or “Fund”).

For holders of the Knights of Columbus Core Bond Fund, Knights of Columbus Limited Duration Fund, Knights of Columbus International Equity Fund, Knights of Columbus Real Estate Fund and Knights of Columbus Long/Short Equity Fund (“Funds” or “Fund”), no required capital gain distribution is expected this year.
